- The bid documents will be issued on payment of Rs.2,000/- per bid document by the Head Clerk (Infrastructure) on written request of contractors from the date of publication of tender notice till 20-01-2020 during the office hours accompanying the following documents:
- 2. The sealed bid documents should be accompanied with Bid Security (5% of Estimated Price as provided Amended PPRA Rule 27) in the shape of "Call Deposit" in favour of Chairman Municipal Committee, Vehari from any scheduled bank and original bidding documents according to PPRA and works rules. The documents will be deposited to Head Clerk M.O(I) Municipal Committee Vehari from the date of publication upto 22-01-2020 till 11:30 AM and will get receipt on Government prescribed proforma.
- 3. All the received/sealed bids will be opened on **22-01-2020** at 01:00 PM in the office of Municipal Committee Vehari by the tender opening Committee in the presence of available contractors or their authorized representatives.
- 4. In case of Tender/Bid not receiving on **22-01-2020** the next receiving date will be **23-01-2020** the above same time.
- 5. It is compulsory on all participating contractors to quote their rates in figures as well as in words on above or below the estimate.
- 6. If the contractor tendered lowest rates equal to or less than 5% of the estimated cost, the lowest bidder shall bound to deposit additional performance security from the scheduled bank from 5% to 10% (including CDR deposited at the time of tendering) within 15 days of issuance of notice. If he does not deposit the required amount, his 5% CDR deposited will be forfeited by the Municipal Committee and his tender rate will be rejected and process of retendering will be initiated. This action cannot be challenged in any court of law.
- 7. Conditional, un-signed, incomplete, cutting, overwritten and doubtful bids will be dealt as rejected.
- 8. The Competent Authority may reject all bids at any time prior to the approval/acceptance of the Tender rate.
- 9. When work order issued to approve contractor, he has to make the agreement with Department on stamp paper of value specified by the Government.
- 10. Time period for completion of each project will be mentioned in work order after approval of rates of the lowest bidder.
- 11. The bids tendered by contractors without 5% CDR will be dealt cancelled automatically.
- The sealed bids should be with original CDR. The bid document not issued from the office of Head Clerk MO(I) will be considered as rejected. The bidder has no right to challenge it.

13. The contractors to whom work order is issued are bound to conduct the required quality control tests at their own expenses.
